

- Open for other BSR organisations to join (new)




BSSSC – THE MISSION

BSSSC – THE STRUCTURE




Board

Climate Change and Sustainable Development I

- Establishment of Baltic Sea Region Joint Platform on Energy and Climate
- Members: Baltic Sea States Sub regional Cooperation (BSSSC), Baltic Development Forum (BDF), Union of Baltic Cities (UBC), Baltic Islands Network B7, Conference of Peripheral and Maritime Regions – Baltic Sea Commission (CPMR BSC), Baltic Sea Parliamentary Conference (BSPC), Nordic Council (NC)
- Focus I: Promote sub-regions as important actors in the discussion on Sustainable Energy and Climate Change
- Focus II: Common Energy and Climate strategy for BSR



Climate Change and Sustainable Development II

- Issues: Greater security of energy supply, better use of energy capabilities, greater energy efficiency, more integrated and competitive energy markets, lower CO2 emission, more renewable energy
- Actions: Support of sound energy and climate-related initiatives in the BSR, Promotion of best practise examples, Cooperation by regularly advising each other on ongoing Energy and Climaterelated activities
- Cooperation with HELCOM and Baltic 21
 Baltic SEA STATES SUBREGIONAL CO-OPERATION

Climate Change and Sustainable Development III - Prospects for activities

- Climate change and environmental issues remain high on the European agenda.
- BSSSC aims to participate in the global debate on climaterelated issues, to promote mutual cooperation and exchanges on best practices and solutions
- Regions can and must participate in ensuring a sustainable development. Therefore the BSSSC annual conference in October 2009 hosted by the region Sealand / Denmark will give input into the UN Climate Change Conference in Copenhagen stressing the regional position
- Close interaction between political decision makers, such as BSSSC, and climate researchers is mandatory
- BALTEX is seen as a prominent candidate for future cooperation
